- Rob Irvin reported on cost for Liability Insurance from Larry Duncan and the cost would be \$715.00 per year. Romaine Dennis checked with Williams and cost would be \$3800.00 per year. Romaine Dennis will get fax from Larry Duncan and if cost is \$715.00 or less will go ahead and put into effect.
- Steve Chandler motioned to fill empty Counsel Seat with Barry Lyon there was no 2nd. Romaine motioned to leave the seat open until next Election, Rob Irvin 2nd, motion carried

- Romaine Dennis discussed complaints about smoking in the Community Building Rob Irvin motioned to ban smoking inside the building Steve Chandler 2nd motion carried. Romaine Dennis will provide No Smoking signs.
- Rob Briggs was recognized to speak and asked if while Vance Bros. was chip and sealing streets if the park areas for the building could be done while they were here.
- Romaine Dennis had been asked by Charlie if the Jamboree was paid up, records checked and they are current and no cleaning deposit is required.
